Dear Chancellor Morgan,

Please accept this letter, attached curriculum vita, and list of references as my application for the position of President for Motlow State Community College (MSCC). I look forward to discussing the possibilities of this position with you. I currently serve as Vice President for Academic Affairs at MSCC. I have also served as Vice President for Academic Affairs and Vice President for Student Services at Kanawha Valley Community and Technical College (KVCTC) in South Charleston, WV as well as Dean for Academic Affairs at West Virginia University at Parkersburg (WVUP). My years in the West Virginia and Tennessee community college systems give me unique experiences to bring to MSCC as its next President. I have leadership experience in the development and delivery of certificate and associate degree programs, as well as technical and transfer programs. My 25 years of experience in community college settings have given me an understanding of the operations of student services and workforce development as well. This understanding is necessary for the executive administrator to ensure that all facets of the institution work together to further the mission of the college.

In 1991 I began my career in higher education. Before that time I was a public school teacher. In higher education I began as an instructor and moved my way through promotion processes to full professor and tenure. I have also served as chair of an academic division, associate dean of academic affairs, dean of academic affairs, and vice president for academic affairs and student services. Through positions associated with these titles I have been responsible for Student Development programs, Developmental Education programs, early admission programs, transitions programs, faculty professional development, adjunct faculty programming, Early Learning Center, Honors College, Leadership Academy, Non-Traditional programs, Office of Retention, Cooperative Education/Career Services, academic advising, program and institutional accreditation, academic programs, curriculum development and delivery, grant writing and workforce/community development. I also have experience with student services areas such as financial aid, recruitment and admissions, disabilities services, and student life. Because of the progressive expansion of responsibilities during my tenure in higher education I have extensive experience with the hiring process, budget management, supervision and evaluation of faculty and staff, scheduling, program development, strategic planning, and leadership development.

While at WVU Parkersburg I was involved in developing the strategic plan for the college, as well as responsible for reporting for the academic area. While at KVCTC I completed the 2012 and 2013 Strategic Plan Report Card for the academic and student services areas. At MSCC we have begun the process for developing the next strategic plan for the college. The goals associated with the college's strategic plan are important benchmarks for all divisions of the college to use. This ensures that all constituents are working to fulfill the mission of the college. The college's strategic plan is the roadmap for the divisions to follow to be sure the college is growing and meeting the needs of students and the community. As President I look

forward to leading Motlow in developing the next strategic plan to meet the guidelines of TBR. I am also excited to guide the college in following the new strategic plan over the coming years.

It is important that the President is involved in the community the college serves. Knowing the community and being known as a community member is vital to building relationships and friends for the college. Not only does this lead to goodwill and an understanding of the needs of the community, but it may also open doors to fund raising. I believe the President, as well as other leaders on campus, should be active community members. In the past I have worked with local Boy Scouts, been an active member of Lions Club, served on Local School Improvement Councils, and assisted with the local humane society. Since I have moved to the Lynchburg/Tullahoma area, I have joined the local Tullahoma Downtown Lions Club. I have also attended the Rutherford County Workforce Executive Council with Dr. Apple. As the President of Motlow State Community College, I must be the face and the voice of the campus to the community. I look forward to greater involvement with agencies and organizations within our 11 county service region.

While I have worked hard to raise funding for programs through grant writing, I have also been a part of other fund raising activities. Just before I left WVU Parkersburg, ground was broken for the construction of a new child development center. I worked with the President to raise funds for the center. I planned fundraising activities such as the "Children's Champions" event, prepared project portfolios and shared them with foundations and private donors, presented the proposal for the center and requested funding from state legislators, and visited with U.S. legislators to request funding for the project. It was a rewarding experience to start with an idea, put it to paper, share the vision with others, and see the vision become reality. In today's economic times, capital campaigns and fundraising are very important roles for the President. Becoming a member of the community and working with the Motlow Foundation will be a focus of my work as President.

I have experience bringing people together from different areas to find common ground for the benefit of the institution. In 2008 I led a group of faculty and chairs to review and revise the general education core curriculum for my college. The core curriculum was a "hot button" issue on the campus at the time. The group worked throughout the year studying models and gathering input from the campus community. By the end of the year we had developed a new general education curriculum that was accepted and approved by faculty, administration, and the college's Board of Governors. As a result of this work, we also developed an experimental model that would allow us to infuse general education skills and knowledge into courses for technical programs. This project was submitted to the WV Community and Technical College (WV CTC) central office as a possible means of encouraging degree completion by students taking classes for skills acquisition and was funded as an experimental program.

The most important skills I bring to a leadership position are listening, observing, and sharing. Community and consensus building are imperative for stakeholders to take ownership in the institution and the programs found within. In the position of President, I am also aware that at times hard decisions must be made and that those decisions are not always popular. I do my best to make informed decisions and in my experience I have found when I must make an unpopular decision and I offer a sincere explanation for the decision, those around me respect my judgment and trust that I am acting in the best interest of the students and the institution. As the chief executive officer of the campus it is impossible to make all people happy. My goal is to create an environment in which faculty and staff can respectfully air their concerns and differences and know that their voice is heard in the decision making process. I believe in using the collective wisdom around me to make the best decisions. Shared governance is a concept that fits well with

my leadership style. As President I must help faculty and staff in the college understand that shared governance refers to balance between faculty/staff participation in decision making and the accountability the executive administrator has to the Board of Regents and THEC, the community and ultimately the students. Through the processes of effective shared governance the mission and strategic plan of the college can move forward. Leadership and team building is a study that is near to my heart and I work every day to make myself a better leader.

The 2008-2009 academic year was a gift to my professional life. I was nominated by my president for an American Council on Education (ACE) Fellowship. After extensive writing and interviewing, I was chosen as one of the 29 members of the 2009 ACE Fellows class. During my year I learned about leadership, hiring, budgeting, funds development, program development, media relations, public speaking, and many other topics related to becoming a president. I was also given the opportunity to visit 36 institutions of higher education, both public and private, across the nation. Valuable time was spent with college presidents and cabinet members learning about all aspects of leadership and stewardship in higher education. Along with the campus visits, I participated in long-term placements with Owens Community College in Toledo, Ohio and with the WV Higher Education Policy Commission (WV HEPC) in Charleston, WV.

During my time at the WV HEPC I was able to observe and participate in the legislative process as it pertains to higher education. I attended staff legislative planning meetings as well as senate and house hearings. I also observed floor debate and learned about working with legislators to advance the agenda for higher education in the state. During Spring 2009 I was asked by the Vice Chancellor to conduct a state-wide study of the program for offering college classes for high school students. To do this I worked with the HEPC Data and Research group to review information collected yearly from all public colleges across the state. I also developed a survey and data tables for each school to complete. As a part of the study I visited several institutions to conduct interviews with the chief academic officers. The report was completed and presented to the Chancellors of the WV CTC and WV HEPC. Because of the findings in the report the Chancellors asked that I lead a task force of chief academic officers to propose a revised policy pertaining to college classes offered for high school students. I worked with the task force from August through December 2009. In January 2010 the new policy was taken to the WV CTC and the WV HEPC and was approved by both governing bodies.

My experiences during the Fellowship year, in addition to my increasing responsibilities at my home college, give me a perspective of various organizational structures. My host college for six months, Owens Community College, was at that time a college of approximately 19,000 students. The campus had three labor unions representing its employees. Working everyday with the president provided opportunities for me to engage in a large and complex organizational structure. My work at the WV HEPC also offered me valuable experience working within the state system structure. I am fortunate to have been given the opportunity in my career to experience large college, small college, and system-wide operations. I have brought this experience to MSCC as the Vice President for Academic Affairs and look forward to using it in the role of President. MSCC is a college within the dynamic TBR system. The knowledge I have helps me meet the requirements and directives of the system while working for the greatest benefit of the college.

At the request of the Vice Chancellor in 2011, I assisted at the state level with the implementation of a Complete College America grant awarded to the state of West Virginia. The grant focused on the redesign of developmental education across the state. The purpose of the redesign is to move students through the

developmental education sequence as quickly as possible while ensuring they have the skills to be successful in their certificate and/or degree programs. The grant involved actual review and revision of developmental programs across the state, offering of professional development opportunities for faculty and staff, and monitoring and evaluation of the changes that occurred. My role was to work directly with the Vice Chancellor to facilitate grant activities and act as liaison for the participating four-year institutions. The work was challenging and rewarding. When I transitioned to the Tennessee system, I was prepared to assist with the redesign of the learning support program. Knowledge of and activities associated with Complete College America also helped me to quickly understand the concepts associated with the Complete College Tennessee Act. During my first year at Motlow we began to take actions to improve retention and completion rates. These actions include: initiating the co-requisite learning support model, completing program maps, writing grants to revitalize gateway courses, creating writing centers, and implementing advising centers on all campuses. We are taking such steps to support student educational attainment, meet performance funding benchmarks, and move closer to the goals of the Drive to 55 program.

Institutions are facing challenging times. In these challenges I look for opportunities. Working with others to find creative solutions and resources is exciting! I challenge myself daily to lead others to discover possibilities that they do not know exist. As an executive leader I find pleasure in helping faculty and staff think outside the box. In today's climate, we must work smart. Smart programming goes beyond traditional methods and meets the educational, delivery, and scheduling needs of the students we serve. As stewards of the institution and community we must never lose sight of those students depending on us for leadership and learning. In Leadership Team meetings, when it seems that an issue cannot be resolved, I often ask, "How can we give the most benefit to the students?" It is our responsibility that students know the pathways available for them whether the student be traditional or nontraditional and in a transfer, AS, or workforce program.

Because of the current economic climate, financial management and growth are vital to the future of any institution. As President this includes advocating for the needs of the college, working to secure external financial resources, and working closely with the chief financial officer to use funds in the most effective and efficient manner. My past experiences have given me increasingly greater budgetary responsibility. As the current Vice President for Academic Affairs and past experience as Vice President for Student Services I had fiscal responsibilities for both the academic area and student services areas. Moving to a system of performance based funding in Tennessee, I realize that I must be aware of the metrics in place to determine our funding levels. As President I will work to ensure that all divisions of the college are working together to meet benchmarks associated with performance funding. Working with all stakeholders to set priorities is important to an effective budgeting process.

During my time at KVCTC I faced many unique challenges. KVCTC is a community college that separated from the four-year university in 2005. In the first 5 weeks of arrival my first assignment was to plan for and move the academic area of the college to a new campus and set up to begin summer school. During the three-days of the physical move, the history making derecho storm devastated a major portion of West Virginia. The new campus was without electricity during our move-in period. As a result of this storm, the completion of telecommunications systems on campus was backed up by several months. Summer school opened one week later than expected and fall term commenced as planned even though we did so with very limited connectivity. Just when we thought we were finding a normal college routine, the

West Virginia legislature passed a bill in March 2013 that mandated the merger of KVCTC with another smaller community college in close proximity. For six months I worked to develop a plan to merge the academic and student services areas of these two colleges. I also worked to complete required Change of Control and Substantive Change documents for the Higher Learning Commission accrediting body. In January 2014 the KVCTC service area was faced with a chemical spill into the region's main water supply. KVCTC campus is about 4 miles down river of ground zero. Because no water was available in the area, I had to quickly work to postpone the opening of the spring term. I brought together teams from student services and academic affairs to ensure changes to the academic calendar that would not be detrimental to students. We worked with the U.S. Department of Education to make accommodations for financial aid assistance and course scheduling. Faculty worked to compress courses. We also brought in donations of bottled water to offer our students who were in need. Because of our planning and actions, we were able to meet the academic needs of our students while being aware of their personal situations. In the face of continual change and challenges I have learned much about myself as a leader. I have found opportunity in adversity and helped faculty and staff find strength in their drive to meet the needs of our students and community.

I believe in the mission of community colleges. Providing an atmosphere that supports the development of individual students in skills attainment, critical thinking, problem solving, and communication helps grow a community of life long learners. I truly understand the importance of opportunities a college such as MSCC offers the community and people of the region. The educational, creative, and cultural experiences provided are invaluable to the intellectual and economic growth of the area. The community college offers access and opportunity to students who may not otherwise attend college. At Motlow we must make the commitment to meet the needs of students who are from diverse and varied backgrounds. As President I will encourage and support programs that engage students from nontraditional as well as culturally and ethnically different backgrounds.

It is important that diversity in faculty and staff also be encouraged and supported. The ideas and experiences brought to campus by new members of the college community add depth and richness to the services and programs that are offered. I have worked with Human Resources officers since I became an academic chair to guarantee fairness in hiring practices. Knowledge of federal regulations associated with affirmative action and equal opportunity are necessary for any person in a position to hire new employees. I have experience finding venues for advertising positions and recruiting through professional networks. A robust candidate pool will enhance the chances for a successful search resulting in the hiring of a new employee who meets the needs of the college.

Building unique partnerships to offer training programs and exploring the various ways to use flexible and distance learning opportunities is a necessity if the college is to grow. I have worked with special programs to meet the educational needs of soldiers while they were deployed and as they returned home. I have also worked to offer programs of training for the Transportation Security Administration (TSA) at airports and with the National Guard for training in the operation of emergency incident command centers. When I left KVCTC we were in process of building a model emergency command center on campus. While at Motlow, I led the development of the college's first Industrial Readiness Training program. This program was developed to prepare workers to meet the needs of industrial partners. Our first, class in partnership with Vi-Jon, was very successful. Being open to, and looking for, opportunities for outreach and

collaboration is a necessary role for the community college in the 21st century. The college and the community it serves benefit from these types of collaborations.

My move to Tennessee has been a positive professional and personal change in my life. As I look to move forward in my career I am excited about the possibilities associated with the position of President at Motlow State Community College. I spent over 20 years at one institution and am committed and loyal to the institution and people I serve. My husband and I feel that we have found a place to call home at Motlow and in south Middle Tennessee. I am a positive person who loves learning and problem solving. I have energy, excitement, and curiosity for new and growing programs and organizations and would like to continue to share my enthusiasm as the next President of Motlow. The mission of MSCC is to offer flexible learning pathways for students in the 11 county service region. I am honored to be part of the team that carries out this mission. I offer my commitment to excellence and loyalty to the college and its students to continue this mission as the next President.

I feel that this letter, along with the information in my curriculum vita, will demonstrate my ability to bring strong leadership to Motlow State Community College. I look forward to discussing this exciting position and sharing my thoughts and ideas with you in the near future. I ask the courtesy of confidentiality until such time that I may be considered a finalist for this position.
